PASTOR NUECHTERLEIN'S REPORT

This has been and up-and-down, and up again, year. As we head into 1998, I am encouraged by a number of things. First, I would like to squarely address the challenges we have faced this past year.

At one of the cottage meetings this past fall, someone asked me if I ever get discouraged on Sunday mornings. My answer was, "Yes, sometimes I do. Certainly, I'd much rather see the church full!" This was an honest answer, but it wasn't my complete answer. There is more I wished I would have said at the time, and so I'd like to say it here in this report.

It is certain that I would much prefer a full church. Yet, while there are times that a halfempty church is discouraging, most of the time I'm not discouraged—at least to the extent that I feel like I'm doing my best to share the precious Gospel which we are called to share.

One of the things that I'm aware of concerning the Gospel is that it is not always easy to hear. In fact, there are times and places in which it seems near impossible for people to hear it. I think there are indications that we live in such a time and place.

Our culture and society do not appear to be good soil for the Gospel. It might be that there is much thorny ground in our time, which Jesus described this way in the Parable of the Sower:

And others are those sown among the thorns: these are the ones who hear the word, but the cares of the world, and the lure of wealth, and the desire for other things come in and choke the word, and it yields nothing. (Mark 4:18-19)

The epitome of the thorny soil in Mark's Gospel is the rich young man (Mark 10:17-27). I remember that when Pastor Mary preached on this text, she quoted in her sermon a theologian who says, "The devil is closest when things are going well, it seems."

Things are going well in our time and place...materially, that is. We have so much in material wealth all around us. But how are things going spiritually? Most people are aware that things are anything but well spiritually, so many folks are searching for something more, like that rich young man was when he came to Jesus.

The trouble is that there are plenty of pretenders out there who offer such seekers something that goes just fine with their material comfort. They are offered and accept spiritual answers in which they can hold onto their love for their possessions. Jesus, on the other hand, makes it clear to the rich young man that love of possessions and love of God don't mix well. Mark notes the man's reaction: "when he heard this, he was shocked and went away grieving, for he had many possessions." How many in our time and place have walked away from the Gospel because they have many possessions?

One of the things that was tempting to do in the cottage meetings this fall was to ask what is working for other churches. How are they growing? How are they getting lots of people in their doors? I'm not sure. I have an inkling that there are *some* (not all) pretenders out there who offer false gospels, though I don't want to sit in judgment of who is or who isn't.

I can only be judge of myself. I can only do the best I know how in remaining faithful to the Gospel to the best of my ability. I sow the seed as best I can and leave the abundant harvest to God, in God's own timing.

And the most amazing grace is that Jesus loves me even when I do fall short of answering his call, just as he loved that rich young man. With Jesus' help I can share that same love with others.

In short, I am more convinced than ever that the Gospel of Jesus Christ is the most powerful thing ever unleashed in this world. Again, it is often a problem to see it as powerful, because the power of God's love looks *totally* different than the powers of this world. But it is the Gospel of God's love that ultimately provides a great motivation for me every day to answer God's call in helping to spread this

Gospel. My sense of conviction grows deeper each day, and there is a joy in answering the call that transcends the day-to-day ups and downs. So when I speak of things that encourage me as we enter into 1998, the Gospel is top of the list.

Why am I so encouraged about the call to proclaim the Gospel at this time when so many seem to walk away from it like the rich young man? As I have shared in the past (even in my call papers before coming to Emmaus, in fact), one thing that keeps me greatly energized for the Gospel these days is the recent work of René Girard. I believe it brings a renewed clarity to the Gospel for our time and place. Other than in the Gospel itself, I have never felt more convinced of anything in my life. I believe Girard's work offers us a working of the Holy Spirit which can guide us in this ministry at Emmaus by helping us to better understand both ourselves and the culture we live in.

Quick example: we have talked in recent weeks about placing an emphasis on youth ministry this year at Emmaus. Yet many, I think, are intimidated by the mere thought of trying to reach out to our youth. When we think of doing youth ministry, our first impulse is to hire some "expert," because we don't feel confident in understanding our youth and their culture. We observe our youth and so often just shake our heads, saying to ourselves, "things are so different-I just don't understand." The work of René Girard not only helps us to better understand the changes in our culture and the things our youth face, but it helps us to see how many of the changes are related, strangely enough, to the Gospel.

Three days after this year's annual meeting, I will be beginning a new Bible study called "The Truth for Our Times." One of the aims of this study of Scripture will be to help us better understand the culture our youth are growing up in, as we seek to reach out to them this year. I hope you will prayerfully consider joining me for this very important study together.

There are a number of other things that encourage me as we enter into 1998. One is the continuing pastoral team with Pastor Mary. It quite simply is the kind of team ministry that I have hoped to be a part of as a pastor. I thank God for the blessing of working with Pastor Mary.

I am also grateful for, and encouraged by, the support of the team ministry by the congregation, which became clear during our cottage meetings last fall. The members of Emmaus really stepped up during the stewardship campaign with a significant increase that will enable the current team ministry approach to continue. Emmaus is a congregation with a rich tradition and history that I look forward to celebrating with you over the next several years as we move toward the 150th anniversary. And the people of Emmaus are both caring and dedicated to the ministry we share. I thank God for the privilege of being your pastor, and for the call to proclaim the Gospel among you in this time and place.

Finally, I remain encouraged about Racine and this neighborhood we are called to serve. We also have an excellent cluster of ELCA churches in Racine, and I think that a cluster coalition approach is coming in the near future, under the guidance of Bishop's Assistant Rev. There are so many exciting Sue Ruehle. And Emmaus' possibilities for ministry. financial need this coming year that requires Pastor Mary and I to offer some hours in another cluster church seems to be playing right into a growing movement to have more cooperation in our cluster. How's that for divine guidance? We were faced with a struggle this past fall, and it has yielded the possibility of leading us into new ministry ventures with sister congregations.

Let us all give thanks to God for the blessings of 1997, and pray for continuing guidance in 1998.

BUILDINGS & GROUNDS COMMITTEE

This past year has been a very busy year with the Building & Grounds Committee. The volunteer support was just tremendous. The following projects were completed:

- 1. Finished painting the grates around the church.
- 2. Repaired the plaster in the kitchen of the parsonage.
- 3. Recaulked the leaks around the steeple and in the new addition.
- 4. Fertilized the lawn with weed and feed twice.
- 5. Scheduled the spring clean-up where we removed a truckload of refuse from around the church. We had 33 volunteers.
- 6. Went over the entire heating system prior to the start of the heating season.
- 7. Re-sided and repainted the utility garage on the alley.
- 8. Rebuilt the fencing around the children's area and replaced the tire with a suitable sandbox and cover.
- 9. Relamped the interior of the church.
- 10. Repaired one of the sodium vapor sidewalk pole lamps.
- 11. Repaired one of the flood lamps adjacent to the front door of the church.
- 12. Rebuilt one of the two wheelchairs.
- 13. Replaced lights in the chancel and the altar cross spot lights.
- 14. Added ½ yard of dirt around the low spot on the west side of the church to prevent leakage.
- 15. Installed new mirrors in the men's bathroom.
- 16. Repaired one of the electrical switches in the men's bathroom.
- 17. Installed new toilet seats in the women's bathroom.
- Removed all lattice from the south and west side of the parsonage and replaced it with cedar trim boards that were painted

to match the trim. Extended the eaves troughs and modified the roof over both the front and rear porches.

- 19. Replaced the large fan that is located in the former church choir alcove in the front of the church.
- 20. Replaced the photoelectric cell on the high pressure sodium vapor light on the east side of the church.
- 21. Replaced the ballast in one of the fluorescent fixtures opposite the office.
- 22. Replaced the starter in one of the high pressure sodium vapor lights south of the church.
- 23. Repainted the church entry, narthex and adjacent areas.
- 24. Repaired the compressor motor that controls the heating system.
- 25. Replaced the front ceiling fan in the sanctuary.
- 26. Repaired the circuit breakers for the sanctuary cove lights.
- 27. Repaired the altar cross lights, replaced all ballasts and electrical connections.
- 28. Replaced one of the tires on the lawn tractor.

Future projects:

- 1. Making operational the indirect lighting on the church cross.
- 2. Replacing guides in the stained glass windows in the sanctuary.
- 3. Recaulking the thermopane above the main entrance to the church.

We have the physical plant in good operating condition and with the exception of the two window projects, everything is in good repair.

The campaign climaxed with a "Blessings Abound" pledge day on November 2. A big thank you goes out to Pastor Sue Ruehle, Assistant to the Bishop, and Daisy the Clown (a close friend of Nancy Smith, although they are never seen together), who preached the blessings of God's grace in such a special way. The day also was highlighted by a successful æbleskiver brunch that fed over 200 people in two sittings. Thank you to Pat Liesch and all who helped with the brunch.

This year's stewardship drive yielded 139 pledges, fifteen more than 1997. Of those pledging families, 66 increased their pledge over the year before and 28 more pledged who did not pledge in 1996. The total pledged, \$160,354.00, nearly matched our highest total in 1995.

WORSHIP & MUSIC COMMITTEE

A new hymnal, With One Voice, was purchased by gifts from the congregation and was introduced by the Adult Choir in 1997. Emmaus continued to use a traditional Sunday liturgical or Service of the Word format from the *Lutheran Book of Worship* for most worship services until spring, when the liturgy from With One Voice was also used. In September, the worship schedule included the use of liturgy from the *Lutheran Book of Worship* twice a month, liturgy from With One Voice twice a month, and the Chicago Folk Service on the third Sunday of each month. Saturday evening services were also provided throughout 1997.

Holy Communion was celebrated on the first and third Saturdays and Sundays every month as well as at special services including Easter, Thanksgiving, and Christmas. The youth and the women of Emmaus provided worship leadership at special services. Lay people have provided support to the pastors regularly by assisting in ministry as readers, worship story tellers, musicians and communion assistants. The Music and Worship Committee met monthly to help plan services and special events. Representatives of the committee are involved in ushering, altar guild, choir and hymn selection.

On April 20, an 8-88 Choir was introduced with an invitation to anyone who wanted to sing to join the group. This proved to be a popular opportunity for many folks to join with the choir for an easy-to-sing anthem. The 8-88 Choir is invited to sing about once every three or four months.

Marsha Connet continues to direct the Senior Choir; and Joyce Kaiser, the church organist, provides accompaniment. We have been unsuccessful in finding a Youth Choir Director and, due to budget constrainsts, discontinued our search for the present. Volunteers have been leading the small children in singing at the Sunday School opening time. Paul Berge has been the accompanist for the Saturday evening services. His music is much appreciated by those who worship at that time.

The Worship and Music Committee continued to identify a goal for 1997 as involving children and youth in worship services and to encourage families to worship together regularly. Joyce Kaiser has worked with several young people during the past year, encourageing them to perform as special music and/or to accompany the Chicago Folk Service. The number of youth who have participated has increased significantly.

New oil candles were given as a memorial gift to replace the altar candles. They were in use by August.

The committee approved holding a Service of Healing once a month on Wednesday evenings at 6:15 p.m.

The Adult Choir participated in a Revival Service at Missionary Baptist Church in September in response to an invitation from that congregation. Emmaus reciprocated by inviting our neighbors at the Missionary Baptist Church to join us at our Thanksgiving Eve service. Their choir performed at that service.

1997 also saw a rather quiet campaign that will be yielding big results for years to come—and already has! Without great fanfare, the 2001 Fund Committee made a simple, direct pitch to do something about the principal on our mortgage—which before the campaign was still over \$210,000 (of an original \$300,000).

Here are the basic results of the four-year pledge campaign (August 1, 1997-July 31, 2001):

Number of pledges:	45	
Total amount pledged:		\$67,440.69
Amount already received	:	\$35,307.69

This has already shrunk our principal to

almost \$175,000 and moved us *years* ahead on the amortization schedule. Donations and pledges to the 2001 Fund are welcome at any time over the next four years, with the hope of bringing us ever closer to a mortgage burning in the vicinity of our 2001 celebrations.

Thank you to committee co-chairs John Knuteson and Ken Pechman, and to their committee, Lyle Christensen, Jim Dougall, and Mildred Schroth, for their efforts in bringing us closer to retiring the debt.

We still have no permanent music director for our Sunday School children. Kathy Christensen and Marie Andersen are temporarily filling this position. They lead our children in fun and song almost every Sunday morning. They also gave so generously of their time to make our Christmas program a success.

This fall, we began using a new curriculum, which seems to be more of a hands-on approach compared to our old curriculum, and is generally well-liked by a majority of our teachers. In 1998, we hope to complement this curriculum by teaching our children Bible stories that we all learned as children. This will take place once a month, in place of our music time.

As always, we are continuing to look for additional teachers, regular and substitute, and new ideas to enhance our program.

June Beck was busy this year sewing 425 bibs for use at Lincoln Lutheran Homes.




To end the year, we traditionally give away our dollars to support good causes. This year, our dollars went to:

NOTES OF EXPLANATION

General Notes

- (1) For the most part, the budget is the same as last year, excepting adjustments for fixed costs (e.g., an increasing gas bill) and salary increases (see itemized notes below).
- (2) The most significant *decrease* is 6511 Regular/Monthly Mortgage Payment. Beginning February 1 the monthly payment is being reduced from \$1927 to \$1490 due to the refinancing of the interest rate.
- (3) The most crucial number in this year's budget is the projected income number for "outside income" (line 4040) of \$8,500. Primarily, this number represents income to be received from another ELCA church(es) in Racine as compensation for Pastors Mary and/or Paul giving part-time assistance in their congregation (e.g., to help during a vacancy). Bishop's Assistant Susan Ruehle has indicated that up to \$10,000 is a reasonable amount to expect, but the details are not yet worked out. If these details are not forthcoming in the early months of 1998, we plan on calling a congregational meeting by May to re-visit the budget.

Specific Notes by Line Item

- (1) 4012: We are able to provide fairly reliable projections for the giving of non-pledging members by totaling what those members gave in 1997.
- (2) 4040: "Outside income" is explained above in General Note #3.
- 6010 & 6020: Our regular benevolence giving is on a percentage basis, 7% for the Greater Milwaukee Synod and 2% for Lutheran Social Services. We use a percentage of regular income for the Unified Fund only. All other designated gifts, including designated benevolences, are passed on strictly as they are designated.
- (4) 6121 & 9151: Pastors Mary & Paul's Base Salaries show significant increases to reflect three main things: (1) cost-of-living raises for *two* years compounded (6.1%) since they did not receive raises last year; (2) merit increases based on the fact that the "outside income" (see General Note #3) depends on a more complex job description for the pastors; and (3) an effort to begin catching up to synod guidelines for pastors' base salaries, after originally meeting those guidelines are: \$26,311-\$30,894 for 6-10 years of service, and \$29,819-\$34,239 for 11-15 years of service. Pastor Mary is in her 7th year of service as an ordained minister (with a proposed base salary this year of \$25,675), and Pastor Paul is in his 13th year (with a proposed base salary of \$29,500; see note #5 below).
- (5) 6151, 6152, 6163 & 6164: Pastor Paul's totals for Reimburse Medical and Continuing Education are higher than Pastor Mary's (with corresponding decreases in salary), because he elects to shift monies from his salary to these two benefits for tax reasons. The amounts before the shift are \$29,500 for Base Salary, \$2257 for Social Security Offset, \$500 for Reimburse Medical, and \$700 for Continuing Education.
- (6) 8181: The suggested Secretary's wages this year are \$8.60/hour for 30 hours/week. The 5% increase reflects cost-of-living *plus* a merit increase based on the continually increasing

difficulty of his job description (primarily due to the increasing difficulty of computer programs and equipment used).

- (7) 6182 & 6434: The suggested Custodian's wages are \$8.76/hour for 25 hours/week reflecting a 3% increase for cost-of-living. The Custodian also receives extra income (and hours worked) through the 6434 Snow Removal line item; and is paid at \$10/hour rate for these hours since they often occur at times other than the regularly scheduled work days and times.
- (8) 6183: The organist's salary reflects a 5% increase for cost-of-living *plus* a merit increase based on a change of job description to include work/preparation on multiple keyboards (organ, piano, and synthesizer).
- (9) 6184: The adult choir director's salary reflects a 3% cost-of-living raise.
- (10) 6185: The position of Youth Choir Director is still currently vacant. We hope to hire a new Youth Choir Director early in the year with the salary projection based on a March 1 start.
- (11) 6189: The Parish Nurse is a new ministry at Emmaus. We are able to fund it at only \$500 in 1998 due to two factors: (1) a gift of volunteer hours from our Parish Nurse, Carol Eschmann, in memory of her father-in-law, Otto Eschmann; and (2) a grant of \$5000 from the Presbyterian U.S.A. church for sharing our nurse with Second Presbyterian Church here in Racine. Our \$500, which we will pay to Second Presbyterian, covers the cost of FICA, insurance, and continuing education.
- (12) 6195: The large increase in Worker's Compensation Insurance is due to the discovery this past year that we were grossly underinsured for the custodian's position, which needs to be insured at a higher rate than the other employees. That error was immediately corrected early in '97 and the corrected figure is now a part of the '98 budget.
- (13) 6201 & 6208: Line 6208 has been re-named as "Worship Resources/Copyright Fees" and then increased in funding to cover for resources that were in 1997 designated as "Altar Supplies."
- (14) 6330 & 6231: Postage ran \$200 over budget this year because we had significant postage costs for stewardship mailings. Thus, for 1998, we are raising the amount for stewardship campaign expenses (6231) rather than postage (6330); and we will correctly designate any stewardship postage expenses to that line item (6231).
- (15) 6322-6324: The primary expense for equipment leasing was our lease-to-buy copy machine, which we now own. We don't foresee leasing any equipment in 1998 (other than the safe-deposit box for \$35). We created a new line item, "Computer Soft/Hardware," to reflect a different category of equipment supplies than the standard supplies (e.g., ink cartridges and copy toner). In 1997, computer software purchases were designated under Equipment Supplies (6323) in the Treasurer's Report, though on this proposal the '97 actuals have been split for information purposes.
- (16) 6511: The \$18,317 total for mortgage payments represents one month at \$1927 (January) and eleven months at the refinanced rate of \$1490/month.
