## Pastor's Report by Rev. Mary L. Janz

Honoring the old, celebrating the new... that is the ongoing challenge for Emmaus as we move forward. When church historians look back several years from now, I would like to go on record as saying that 2008 may very likely be considered as a pivotal year in the history of Emmaus.

Why has the past year been so significant in the life of this church? Consider the ways God has been at work,

challenging us and blessing us and loving us... and bringing us new opportunities.

The congregation faced a significant deficit of nearly \$20,000 at the very time a national recession had taken hold last fall. A number of families who were able generously stepped forward with extra mile giving. That, together with attempts to turn the heat down and to be even more frugal, led to a year-end deficit of under \$6,000. All obligations have been met, including our annual benevolence giving of \$10,000 to the Greater Milwaukee Synod. I am so grateful for the strong commitment and generosity of the members of Emmaus!

Generosity and specially designated gifts have made it possible to make advances that were not budgeted for. We have added an up-to-date nine telephone system as well as three new wireless microphones. Other gifts made additional landscaping possible. A challenge for 2009: Will we be able to replace the 50+-year-old stove (that has only one working oven) in the coming year? A stove fund has been established for special gifts for that purpose.

Many other gifts come with faces and names, and we are even richer because of them. Little did we realize that Jhon Freddy Correa's visit in mid-February would grow into new relationships and possibilities. Early on, Jhon Freddy aptly coordinated the Fiesta Mexicana and since then has worked with Sandy Strini to develop the youth



group. Additional classes at the seminary in Chicago and development of a Latino ministry are on the 2009 calendar of this very busy young man.

With our younger leaders, the face of our worship life is transforming. Power Point presentations, a praise team, "God Tube" videos and alternative liturgies with more contemporary music have been part of several worship services. Caren Lamberton, Becky Smurawa (our new choir director),



Brenda Trumbauer (our new accompanist), Claranna Vytlacil, Jhon Freddy, Ryan Lamberton, Gregg and Kylee Albright have spent countless hours in bringing new life to worship. They welcome feedback as they continue to create.

Another new face on our staff this year is that of Abelino Mares, our custodian. Abelino, together with his wife, Manuela, brings a strong work ethic and a "can do" attitude to his position.

I am in awe of the able and committed people who are the long-time and familiar faces here as well; ministry wouldn't happen without them. I give God thanks for Nancy Smith, Valerie Crehan, Pastor Walter, Claranna Vytlacil, Paul Berge and Joyce Kaiser. And, what would we do without Pat Jensen, and Carol Yust (and family) in our kitchens, and Carolyn Wooster, who spends many hours as our treasure?

From altar care to member care, from worship to outreach, from education to service, from garden to kitchen, from sanctuary to neighborhood... we are all called to be fed, to pray and to serve. Thank you to all who say "Yes!"

What will the role of Emmaus be as we look at "Racine Mission Field 2009"? How will we be called to lead? Where are we being challenged to collaborate? As we look at the resurrection symbol of the emerging butterfly, what will be part of that chrysalis that must be shed — and what will remain — that we may emerge with new life and vitality? That is the challenge and that is the opportunity. Let's be alert and bold as the Spirit calls us, saying, "Behold, I make all things new!"

In the words of Pastor Walter, let us "expect grace" — even in the most unexpected places. I can't wait to experience those Spirit-led miracles and grace moments as we move forward in faith together, recognizing the greatest gift of all, Jesus Christ in our midst.

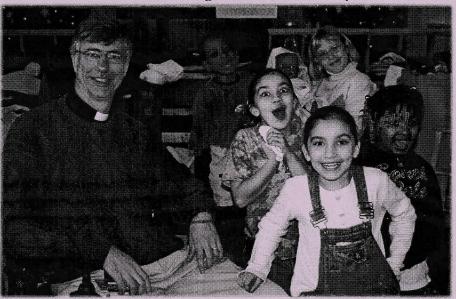

This has been quite the year for Emmaus. The journey continues in this my second time as Council President. In this year there have been and continue to be positives, but also challenges. The positives have been:

The Alliance of ELCA Churches, (St. Andrew, St. Paul, Emmanuel and Emmaus) has grown stronger and we have added Lutheran Church of the Redeemer. We continue to meet monthly rotating sites; this is led by the council presidents and clergy attending. Things that we put into action were: Five Church Son Rise Service at Memorial Hall with attendance first time through of 100. Joined Lutheran Church of



the Redeemer for a service at the Zoo in June. Joint Service at Mass on the Grass at Emmaus. To finish out the year, Harvestfest at St. Andrew in the Fall.

We tried a Summer Wednesday service, but due to attendance cancelled it.

Wednesday continues to grow and is out pacing the traditional Sunday Service.

Bible Studies are offered on Wednesday.

The addition of Jhon Freddy to the staff and the ability of all the ELCA Churches to assist in the funding of his Seminary Studies. Jhon along with Nancy Smith ran the Summer Program for the children at Emmaus, Emmanuel and Lutheran Church of the Redeemer. Jhon's role has expanded to include working with Sandy Strini and the youth at Emmaus and Lutheran Church of the Redeemer. This has led to an increase in the youth at both places and has enabled us to expand the work in the community.

These are a few of the positives here at Emmaus!

Now the challenges:

To continue our growth we will need more assistance from you as members. We finished the year 2008 with a shortfall due to weather issues, as well as economy issues. ## Building & Grounds Annual Report by Loren Larsen

The Buildings and Grounds Committee is basically responsible for the every day up keep of the Church facilities. Minor projects such as replacing deteriorated light switches and electrical outlets, replacing light bulbs, fixing leaky faucets and stopped up bubblers and installing and removing the air conditioners are examples.

We also took on some more complex projects. The torrential rains we received this spring caused some serious ground water infiltration into the church basement

in several areas. One of the main areas of concern was located at the front entrance, where the deterioration of the block wall under the stoop and settled concrete sidewalk caused water to leak into one of the closets in the basement. This area was repaired by Katt Construction which removed the sidewalk around the stoop, repaired the deteriorated section of the basement wall, and then replaced the sidewalk. The

other area of infiltration was located along the west side of the new addition. Here, water infiltrated through the ground level basement windows. For this problem, we attached galvanized window well enclosures around the basement windows and then ran perforated plastic drain tile along the west side of the building and connected the drain tile to the church storm sewer. Some of the other projects we worked on were cleaning out the boiler room and garage, adding electrical outlets to a Sunday school classroom, selling our old lawn tractor and attachments and having the door closer rebuilt for the front doors.

I would like to personally thank the current members of the Building and Grounds Committee, Rich Christensen, Ron Jensen, and Lyle Christensen. Their enthusiastic help and expertise made these projects fun to work on.



As for the up and coming year, the Buildings and Grounds Committee will be looking at trying to stop the leaks from the church steeple, working with Pastor Mary to replace the ovens in the kitchen and pretty much anything else that comes our way.

Visitation Ministry is our direct contact with our members in need, those who have experienced a loss or sickness, or are homebound or living in assisted care facilities. These visits may be in person or by mail or telephone. This year, we developed a Member Care Log to help track our contacts. This log is located in the narthex or by the church office and may be used by anyone to let us know of visits you have made. Thanks to June Beck, Betty Breiwick, Karen Christensen, Kathy Christiansen, Ruth Copeland, Carol Eschmann, Michele Kreimer, Jim Larrabee, Evelyn Larsen, Karen Sedgwick, Al Svendsen and many others who have visited members.

Greeting Card Ministry continues to remember Emmaus seniors on their birthdays. We thank Ruth Estep for her many years of providing this service.

Parish Nurse Ministry is provided by Carol Eschmann. She monitors blood pressure for 12-15 members every first Sunday of the month after worship service

and continues to be available as a resource for health questions and family issues.

Prayer Shawl Ministry meets weekly and has provided over fifty prayer shawls to those experiencing serious illness or surgery. In addition, the group has knitted and crocheted dozens of hats, scarves and mittens that have been distributed to Wadewitz School students, Emmaus After School Youth, and Emmaus members, as well as lap robes and afghans for use at church services. Thanks go to Dorothy Bagley,

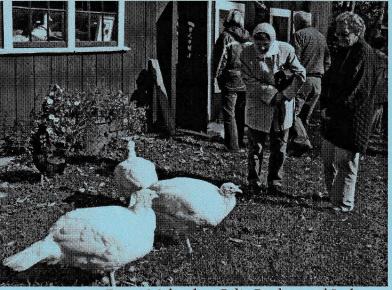

A set of four short books, entitled *Journeying Through Grief*, is sent at four crucial times throughout the year. In the past eighteen months, over twenty sets of books have been mailed.

Telephone Ministry is a way to contact all members of Emmaus to update address and phone information, as well as connecting with everyone on a personal basis. This is an on-going process, and we thank Michele Kreimer for taking on this time-consuming activity.

Transportation Ministry is a new service that we are offering to Emmaus seniors who would like to continue attending worship services, but are unsure of driving in winter weather. Thanks to



Diane Melander, Celia Bagley, and Judy Yorgan, who have volunteered to help. Thanks also goes to Pastor Mary for her continued support of these ministries. Together we can spread God's love. Respectfully submitted,

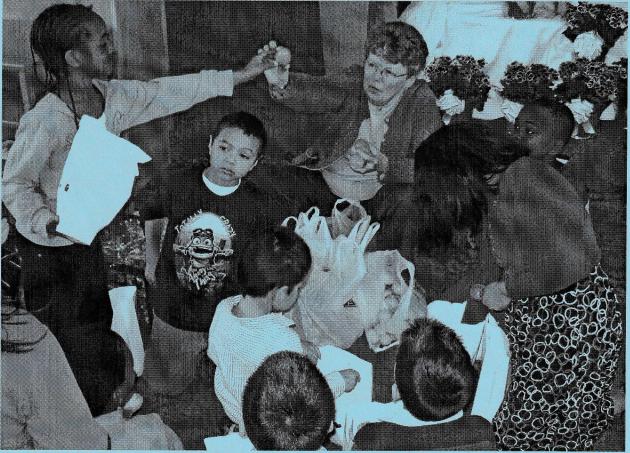
## Parish Education Committee Report by Marty Aiken

## Social Concerns Committee Report by Diane Melander

As a new council member this past year, I've enjoyed learning about all of the wonderful projects here at Emmaus that are a part of our Social Ministry. We've been blessed with so many members who joyfully answer the call to help serve. Thanks to all of you who have contributed so much of your time, talent and resources to our social ministry.

A new project this year is Mt. Meru Coffee. This program is non-profit. We sell the coffee to help the Tanzanian farmers receive a fair price for their crops. The coffee growers of the Mt. Meru region of Tanzania were making very little money on their small coffee farms. This project has helped the farmers by giving them a fair price for their coffee crops. It also helps the farmers to increase productivity. We pay no postage on our coffee orders and we receive no profit on the coffee we sell. Our first coffee was ordered in April 2008. Since then we've ordered 168 twelve ounce packages, five 4pound packages of coffee and seven prepackaged gift bags for coffee. We currently have on hand twenty-five 12ounce bags of coffee.

Mt. Meru Coffee is sold every Sunday morning between services and is available at the Saturday service. Anyone wanting to order coffee may do so on Sunday or call me at 262-681-2796 or contact me online at: emmauscoffee@me.com. 12-ounce packages of coffee are available for \$9.00 each. 4pound bags are available at \$40. The coffee is available in regular, decaffeinated, whole bean, drip grind and percolator grind. If you'd like more information about the Mt. Meru project, you may go to their web site at www.mtmeru.org or contact me by phone or e-mail. Additional coffee volunteers are always welcome!

The Emmaus Scrip program is doing well, and is also offered every Sunday

morning at coffee time. In addition to that, a small portion of your grocery store purchases at Pick 'n' Save can be donated to Emmaus. Stop by the service counter and ask them to make Emmaus your choice charity by giving them this number: 205100.

We've helped the Northside Food Pantry this year with many generous donations of time, food and money. Several members participated in the Walkathon and Harvest Festival for Hunger, held at St. Andrew's Church in September. Their proceeds went to the Food Pantry. The Souper Bowl Sunday change will also be donated to the Northside Food Pantry.

The Knit One Purl One group has made and donated many prayer shawls to members and friends with health concerns. Also, a number of hat, scarf and mitten sets were donated to children in the EASY (after school program), Family Literacy Program and Wadewitz students. At Christmas, the Knit One Purl One ladies wrapped the gifts purchased for the EASY, Family Literacy and Wadewitz families that were part of the Giving Tree program.

In addition, many people continue to give of their time, talents and resources in many other ways. We also continue the Community Meals Program. Thank you all for the love and support you've given to the Social Ministry of Emmaus.

The Worship and Music Committee met on the first Monday of each month and worked together planning worship services as well as addressing all aspects of the worship experience at Emmaus.

#### Worship Services

Many of the events remained the same and yet many changes were also made throughout the 2008 church year. The Sunday service has been enriched by adding new flavors to the liturgy and music. The service schedule now includes a traditional worship service, a Service of the Word, a Chicago Folk service, and a Contemporary service each month.

## Youth Ministry Report by Jhon Freddy Correa and Sandy Strini

On March 14<sup>th</sup>, we participated in the annual "30 Hour Famine," a time where the youth of Emmaus combined efforts with the youth of Redeemer (for the first time); not only for fasting, but sharing, playing, sleeping, helping others and praying together. Twenty four of us gathered together, led by the Youth Encounter group: Anthony, Jules, Hannah and Amber. It was a great experience for everybody, including the adult participation.

From February to May, the youth group gathered every week on Wednesday nights for one hour with the Youth Encounter group for games, reflection and prayer.

In April; some of the youth helped with "Fiesta Mexicana," although it was not planned, there was spirit of cooperation and solidarity, helping out with this activity; going out to collect prizes and a lot more.

Friendship and trust are growing among youth in Racine! A week-end confirmation retreat at Lutherdale Bible Camp in May announced the ending of their gatherings on Wednesdays.

Summer brought not only the charm and warm weather but the gracious presence of some kids from our neighborhood (Neighborhood Camp), and here again some of our youth were a great help; they were accompanying, teaching, playing, giving their free and personal time to others and to the Church. Also some of

the kids wanted to meet during summer time; we tried to meet but it was not that successful in number, although it was in quality.

When the school year started in September, our youth gathered again every week; this time we started with a very low number, I believe 2-4 kids; then every week from "nowhere" kids kept showing up, adding a total of 32 kids for this fall semester 2008. Some of the kids participate during worship, with readings, songs, and others setting up for the worship service. On Wednesday night, one hour was barely enough to laugh, get caught up with what was going on, learn, plan, and pray; that they decided themselves to start showing up at 4:30 pm, even though that was not what we planned, intended it; but we did manage it!

We created different committees within the Youth group, giving them ownership and the possibility to develop their leaderships skills. In our agenda with added the church theme "We Say Yes" and reflect upon it. Guest speakers such as a deaf person and a young person to talk about AIDS were also part of this experience.

On October 26th, Reformation Sunday, two of our youth affirmed their baptism and were confirmed: Mason Bagley

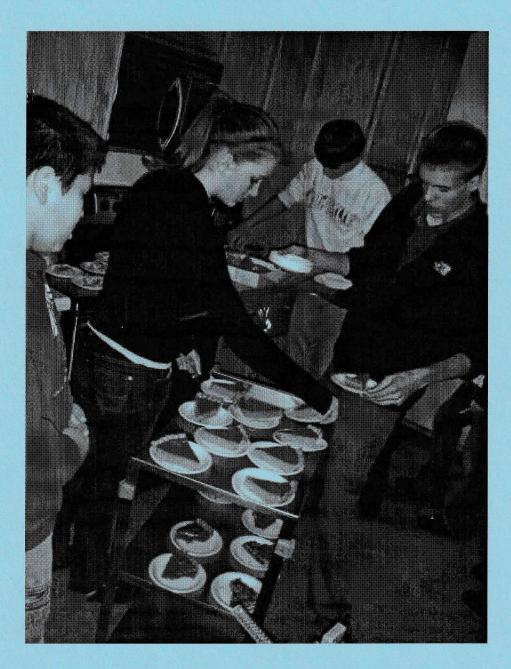


and Jennifer Haman.

This fall, our middle school kids joined Redeemer in the GIFT- "Gathered In Faith Together." We met once a month to reflect, learn and share experiences. Our teaching focus was on "Life in Baptism." We also had an opportunity to visit and share with the residents of HALO, Racine's shelter for the homeless. It was a remarkable experience for our youth! Moved by this experience, our youth cooperated and worked together with other youth; putting a total of 30 food baskets together for the season of Thanksgiving and Christmas. Our youth helped sort all of the donated and purchased food to create the food baskets. On two Saturdays several of the young people where involved in helping deliver the food to the families receiving the gifts. To help the youth think about what food products are necessary when you have a limited income, they put together a list of food they thought was important to survive on. They thought about needs in terms of food products rather than wants. Studying the scripture about feeding the 5,000 helped them comprehend that a little can go a long way. We were all blessed by seeing the outpouring of love and charity to create our food baskets. Thank you Emmaus families so very much.

And now we are ready 2009 and for the Mission trip to Yakama-Washington in July 2009!

## Outreach Ministry Report by Nancy Smith

Emmaus Outreach: Emmaus continues to be a beacon in our community with several programs reaching out to the underserved population of our neighborhood.

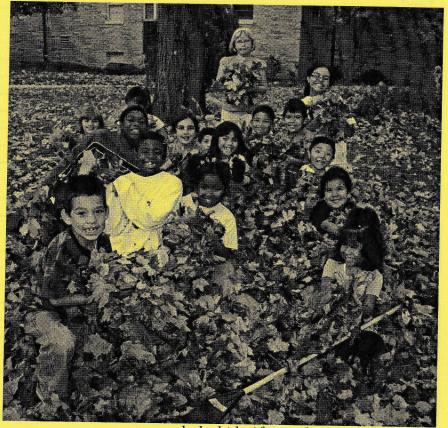
Mentoring: Once again the members of Emmaus have stepped forward and volunteered their services to work with kids at Wadewitz Elementary. Kathryn and

Marty Aiken, Kylee and Gregg Albright, Judy Berndt, Kathy Christensen, Ruth Copeland, Carol Eschmann, Julie Field, Joy Lippmann, Diane Melander, Missy Porcaro, Nancy Smith, Al Svendsen, Beth Tepley and Judy Yorgan have said, "Yes!" Mentors spend from 30 minutes to an hour with their special student offering encouragement in academic areas where needed. There are times when conversation is appropriate to offer hope when problems arise in personal relationships. The mentor and student may read a book together,

create a craft project or play a game. Many of the kids do not experience positive acknowledgement for their place in the world. Mentors provide a light for them.

Wednesday Camp: Wednesday evenings provide a compilation of many different activities for our members and neighborhood kids, e.g.: supper, music, Bible study and worship. The kids enjoy a meal prepared and served by Carol Yust and family. In October, Second Wednesday Suppers were initiated. This gives additional members an opportunity to cook and serve sloppy joes to the people who attend. Registration for this program includes 32 children.

Music has been added to the Wednesday evening mix. Every other week we are fortunate to have Terrance and Curtis from All Nations Church come and



teach the kids African drumming. The kids are very excited about this new opportunity. The walls of the church reverberate with the rhythms they are learning. Brenda Trumbauer accompanies the kids on the other Wednesdays and when they sing/perform on Sundays. Because of her support, the kids have been able to learn music that has given them the chance to sing in church on Sundays. What a thrill to sit in the sanctuary Thanksgiving Eve as the Kid's Choir and the Adult Choir joined ranks to sing an anthem.

Bible study was led by Claranna Vytlacil and Nancy Smith. The beginning of the year the kids studied about the Lord's Supper. Many of our kids had the privilege of taking their first communion in January. During Lent they gained a better understanding of the passion of Christ. The highlight of this area of study was a presentation of the last week of Christ complete with the laying of the palms during Christ's entrance into Jerusalem, foot washing, communion, prayerful time in the garden, the arrest of Jesus, the trial, the



crucifixion and a visit to the tomb. Stations of the Cross were created throughout the church. The tomb was in a candlelit basement – the kids had to enter by crawling on their knees. Upon leaving the tomb, they left behind a black ribbon in which a nail had been placed. It was a moving experience for all involved. Jhon Freddy Correa and Chris and Ryan Lamberton were instrumental in making this time of special worship a success.

In Spring, we moved on to learning about some of the miracles of Jesus. This fall we studied the Ten Commandments. One of the highlights of this study was an interactive visit by Moses played aptly by Brian Crehan. The kids also created a Ten Commandments tower depicting each commandment on a large carton.

The Christmas pageant offering this year was something new: *Matt 'n' Lucy's Version Births.* It was a unique way of teaching the kids as well as adults that there are two versions of the Christmas story as revealed in the books of Matthew and Luke. The kids did an awesome job as they were required to learn many original songs. As they read their scripts, the two main characters Matt and Lucy were scratching their heads as they realized the scripts were quite different. Matthew talks about the

wise men while Luke mentions shepherds. One had angels speaking with Mary; the other said angels spoke to Joseph. Both were in agreement when it came time for Mary and Joseph to enter with baby Jesus.

Neighborhood Camp: Thanks to theo many volunteers from Emmaus, Neighborhood Camp provided another safe, free, and fun-filled summer for 50 kids ages 6-11. A special note of thanks to Celia

Bagley, who organized nutritious lunches for our campers. Marge Zielke, Denise Keller, Kathy Denneau, and Missy Porcaro spear-headed and served the breakfast meal. Led by site coordinator Nancy Smith and with the help of two assistants, Maribel Velasquez and Becca Ruidl, and six teen interns, the campers had a varied summer of activities. A middle school volunteer also worked diligently with each intern.

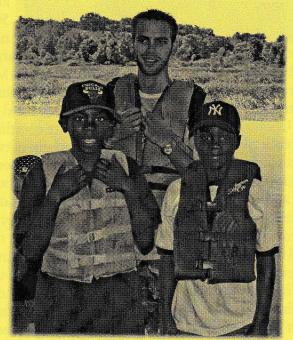
The themes this year include Fit as a Fiddle, Discovering China, Singin' in the Rain Forest, Power Lab and How Things Work. One of the highlights was the introduction of the character "Womocel" (part woman, mosquito and elephant) who developed all kinds of ailments. Each day Kelsey Albright, who is studying nutrition, presented the symptoms using manipulative props. The kids had to look up in books or on the computer what caused these symptoms and how they could be remedied. Because of the emphasis on nutrition, our kitchen crew did an outstanding job of designing and preparing healthy breakfast and lunch menus.

"How Things Work" introduced the kids to incubators and the chance to witness the hatching of several chickens and a duck. That duck, dubbed Speedy, stole everyone's heart and became the camp mascot. He entertained the campers daily with his antics. It was a sad day when Speedy was delivered to his permanent home at Eco-Justice. The kids, as well as many who met him, still ask about their grown-up friend.

As a result of our relationship with an area educational toy store, the campers were gifted with their own personal WebKinz (a series of animals that require computer usage). This was an amazing opportunity for the campers to assume responsibility for the care and nurture of their friend. Many

of the campers report they are continuing to care for their animal.

Always high on the interest of the kids are field trips. We visited the Eco-Justice Center, Audubon Nature center, Bong Nature Center, and, as part of our service to others, we visited and played with the residents of St. Monica's Senior Citizens Home. The campers also visited the Racine Public library to



take in the musings of David Stokes, a clever and learned man of nature and the environment. A special activity this summer was the raising of a 24-foot high climbing wall on the Emmaus field. All the campers and staff had several chances to attempt the wall. Many were proud and excited to reach the top.

An important aspect of the summer camp experience is the sharing of God's love. Each day God time was led by Pastor Mary and/or Jhon Freddy. Bible stories were selected so that they relate to the theme of the week. This year there was an emphasis on presenting stories through drama. Each older group had the chance to dramatize their version of a story using costumes and props. One such story of the paralyzed man who was let down through the roof was followed up with the kids having a "trust" exercise. With back boards borrowed from the Racine Fire and Rescue. the kids took turns carrying one another throughout the halls of the church. Much emphasis is placed on how much God loves them. They are reminded again and again that they are God's special kids.

As part of remembering and doing for

others, the kids continued their tradition of collecting lose change and recycling aluminum cans. This year's recipient was Children's Hospital who received a check for \$325.00. Thanks to all who provided their time, talent and money to help Neighborhood Camp give hope and love to a few of God's special kids. Yes, ministry happens in a very big way at Emmaus! ## Neighborhood Minister's report by Jhon Freddy Correa

On the morning of February 17, the coldest and iciest day of the month if not of the whole last winter, I came to meet for first time Pastor Mary Janz. After worship on Sunday and a couple hours of talking, I went back to Greenfield, where I used to live, without a promising future here in Racine.

With faith, hope, fear, pain, but no time; I kept trusting in our Lord, "who makes out of nothing, something; who takes nowhere and makes it somewhere; who takes nobody and makes them somebody." Emmaus Lutheran Church took the risk without anything, and that's how we started this adventure on March 15. the beginning of a promising sign. With only one month of preparation and planning, more than 100 raffle prizes were donated, food, two hours of Mariachi music alive for 450 people and a lot more! I continued to encourage people to trust and invest in me.

I participate in May in the youth retreat at Lutherdale, as well in the Synod Assembly –weekend retreat- on May 29-31. As I was getting ready for Summer Camp, during the week of training I finally received a notice from the immigration department that my immigration status needed to change. Nothing was clear at this point; only that I was helping at summer camp,

A couple of days were enough to create the first attractive experience that helped to expose my creativity, enthusiasm and a lot more to people. After that, a few other presentations and Bible studies at Emmaus kept echoing my name and what I was doing.



After several conversations and a period of time when Lutheran Church of the Redeemer heard and got to know me a little better; also Redeemer took the risk and opened its doors, not only to me, but to my wife. The weekend of May 25, we moved into Redeemer's parsonage.

I began learning, getting to know people, changing legal status with the Immigration department, preparing for "Fiesta Mexicana" and a lot more! I took my first seminary course in April, called "Good News for the City." During all of this I needed to lead "Fiesta Mexicana"! It was attending the seminary and taking another class in July – maybe even going back to Colombia. But once again, our God, who makes out nothing something, figured it out! My status as a student was confirmed!

Preaching, sharing and helping with other groups in the churches- Emmaus-Redeemer- taking a class, helping at summer camp at Redeemer and Emmaus, praying, meeting and filling forms for my immigration situation, connecting with people from the seminary in Chicago, also with the Synod office and the wide churchLatino churches in Milwaukee were some of the things that I did during summer.

As the youth say today, "It is show time!" For me, "show time" meant leading and coordinating the summer Camp at Emmanuel Lutheran Church. It was only two weeks before camp started, with nothing planned or prepared, and only nine kids from this church. This camp turned out to be, probably, the biggest camp in Racine, with the resources only for regular camp-25 kids- turned out to be a camp with 52 kids! All this was possible because of some of you who are reading this and also many others that trust and love the church of God.

I finished camp on August 21 and enrolled and started seminary three days later! Being a full time student at Lutheran School of Theology in Chicago solved my immigration status. Now I am a student, commuting twice a week to Chicago (Monday and Thursday (9:00 a.m. to midnight). I continue to help on Tuesday at Redeemer's "Terrific Tuesdays" and Wednesday at Emmaus' afternoon and evening activities. I preach a least twice a month at both. I continue to build and strengthen connections at the seminary and the Synod. This is a little bit of my life from year 2008.

Lastly, my dreams for next year are: In the first half of the year to create a heart in Racine for a much-needed youth ministry. One project will be to lead Mexican Fiesta. I will be living in Chicago at the seminary from Monday early morning through Wednesday late night (probably from Sunday night, my first class starts at 9:00 am on Monday). Then Thursday I will be at Redeemer helping with the Bible text study and seniors. Saturday: youth group. Sunday: every other week at Redeemer and Emmaus. It may be that some Sundays I will have to visit some others congregations and preach (as I did this past semester at Bethania-Racine, Holy Cross-Menominee Falls, and Faith-Milwaukee). This coming semester Atonement, Holy Cross and Mount Pleasant in Racine would like me to preach and share with them. This extra preaching helps me to pay for my seminary studies and the monthly \$1,000 stipend.

Another dream I have is to be able to attend to the needs of the Latino community in Racine and be able to provide a worship service in their own language.

#### Scrip Annual Report by Cathy Meyer

Emmaus has participated in Scrip fund raising for several years. Scrip is a term that means "substitute money." When Emmaus members purchase scrip, they're purchasing gift certificates that are used just like cash. Scrip is issued by retailers where many of us already shop; and by using Scrip to purchase everyday expenses like food, gas, and other essentials, we earn revenue for our church.

Because the Scrip gift certificates are purchased with cash up front, the retailers offer a substantial discount, from two to fifteen percent, and that is retained by Emmaus as revenue. Thanks to so many of you who purchase gift cards through the Scrip program, we have realized a profit in 2007 of \$1,789.35, and in 2008 of \$1,601.25, a total of almost \$3,400 in the last two years! Our profits have been put toward unexpected expenses such as the replacement of a window air conditioner in the church and the replacement of the heating system in the parsonage.

We will continue to sell Scrip after worship services in the coming year. Watch for announcements in the bulletin about specific retailers who participate so that you can plan your Scrip purchases.

## Racine Family Literacy Annual Report July 1, 2007 – June 30, 2008 by Richard Marciniak

2007-2008 was another successful year for Racine Family Literacy.

Executive Director wrote 16 grants. Net income for 2007-2008 of \$10.49. Monthly book giveaway continued

with books donated by CNH, First Books, and Reading Is Fundamental.

Racine Family Literacy provided 1-3 inhome developmental assessments done with parents for all children birth to age 6. RFL now provides direct, on-going services for each of Success By Six's three "Quality Systems": health care, social services, and education. In January, 2008, RFL also received a United Way "Caring for Kids" grant to expand what it does with children 9-16 years of age. These and other changes have moved RFL from being a "program" to an organization providing comprehensive literacy/social services.

Racine Health Department Nurses visited three times to do tooth varnishing and referrals for dental work.

Average income of families served: \$19,901. Average family size is 4.3. Below poverty guidelines: 33 of 45 (72%). 43 of 45 (96%) qualify for free or reduced school lunch (below 185% of poverty guidelines).

In 2007-2008, Racine Family Literacy served 42 families, with 53 adults and 90 children: 143 participants unduplicated; 3,793 duplicated; with 7,508 hours of direct contact — class and home visitation time. (Home visits were counted as serving one, although many provided services for multiple family members.

#### **RFL** Achievements/Highlights

August, 2007: provided school supplies to continuing families for sixth consecutive year.

September, 0207: moved into two new rooms at Emmaus Lutheran Church. RFL

now has five classes for children from birth to 16 and three for adults. Dollar General Literacy Foundation, Roundy's Foundation, and United Way provided funds.

October, 2007: received a Target Foundation grant for art field trips.

November, 2007: received a Wisconsin Technical College System grant for adult education software; Barnes and Noble Story Hour celebration of National Family Literacy Day (November 1).

December, 2007: received a First Book grant for monthly free book distributions.

January, 2008: received new United Way "Achievement Now" grant, to work with children ages 9-16. The grant has three goals: 1.) increase skills in core subject areas, especially reading; 2.) build assets connected to success in school — positive attitude about learning, reading for pleasure, daily homework time; 3.) build social assets — learning about the world and expressing care — through extended field trips and service projects.

February, 2008: received a Racine Junior League grant for extending field trip program to support children's and families' learning; received Reading Is Fundamental grant for third year — funds book giveaway.

March, 2008: received a second grant from Roundy's Foundation to continue Pre GED class next year. Prevent Blindness visited, providing free vision screenings for adults and glaucoma test. Lenscrafters' Gift of Sight Program provided free eye exams/glasses for five adults.

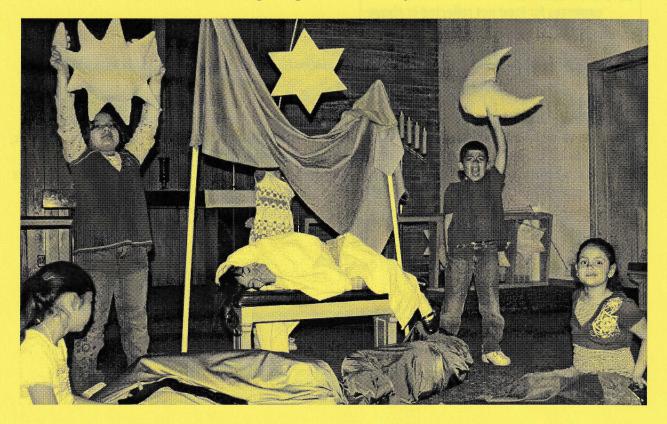

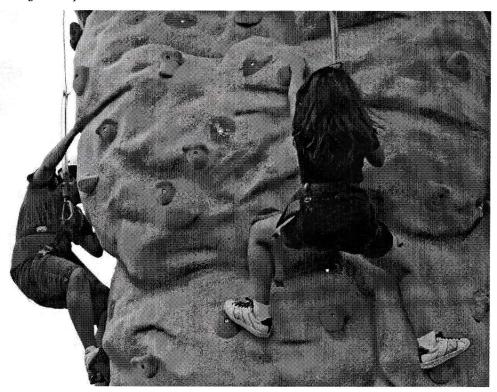

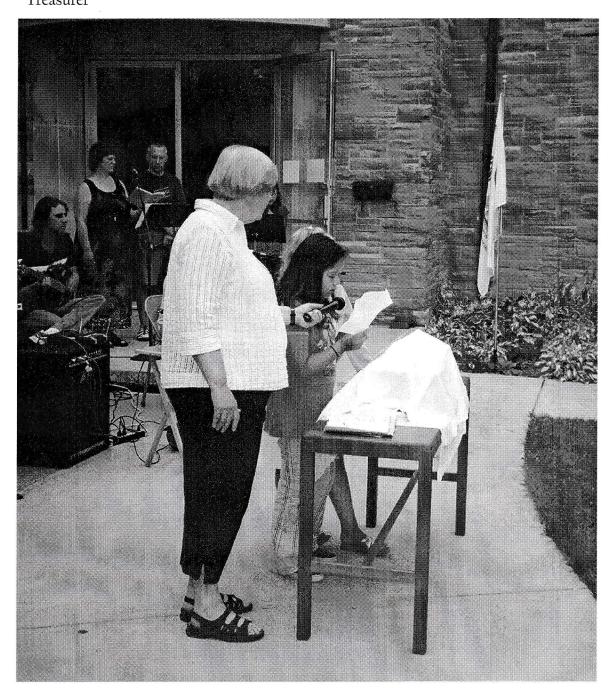
